1) ELIGIBILITY:

A pass in H.Sc./10+2 (or) an equivalent examination from a recognized Board with minimum 50% in aggregate. The candidate should have studied in Physics, Chemistry and any one of following:

Biology (or) Mathematics (or) Computer Science (or) Statistics (or) Electronics (or) Psychology (or) Biotechnology (or) any Science subject.

Candidates belonging to any State / Union Territory of India only are eligible.

5) ANTI-RAGGING MEASURES:
