3) IMPORTANT NOTE

- a) Candidates are advised to check the website of DGHS (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and college website: www.vmsdcsalem.com from time to time.
- b) Allotment letter given by DGHS for admission is subject to fulfillment of all eligibility criteria prescribed by the **DCI** and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and not found medically fit will not be admitted to the course of study to which they are allotted by the DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) The University reserves the right to change the rules relating to examinations, refunds, etc.
- d) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, of Vinayaka Mission’s Research Foundation (Deemed to be University) and Vice-Chancellor’s decision shall be final and binding.

4) REFUND POLICY

01	In case of re-allocation / resign after the first round of counseling	Only 90% of the tuition fee will be refundable.
02	In case the candidate resigns after second round of counseling.	No refund of tuition fee & other fee.
03	If candidate resigns after the last date of admission as prescribed by the DCI	The entire Course fee has to be paid by the candidate.
04	Penalty to be imposed if any candidate resigns / withdraws from the course resulting in rendering the seat vacant.	If any candidate discontinues the course and the seat is rendered vacant, in addition to the forfeiture of the first year fee paid, the student have to remit the entire course fee for the remaining years of the course period.

6. Internship Completion Certificate from the Head of Institution or College that the candidate shall complete the Internship by **31st March of the year of admission**.
7. Permanent / Provisional Registration Certificate issued by DCI / State Dental Council. Provisional Registration Certificate is acceptable only in case where candidate is undergoing internship likely to complete the same on or before **31st March of year of admission**.
8. High School / Higher Secondary School Certificate / Birth Certificate as proof of Date of Birth.
9. The Seat allotted Candidates must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for NEET i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
10. The Candidate should also bring the following certificates, if applicable
 - a) SC/ST Certificate issued by the **competent authority** (in the format as specified in the prospectus) and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
 - b) OBC certificate issued by the **competent authority**. The sub-caste should tally with the Central List of OBC. The OBC candidates should **not belong to Creamy Layer**. The OBC certificate must be in the format as mentioned in the prospectus.
 - c) Orthopaedic Physical Disability (Physically Handicapped (PH)) Certificate issued from a duly constituted and authorized Medical Boards. ***No other PH certificate, issued by any other Authorities / Hospital will be entertained.***
