Instructions to the Candidates

BASLP (Bachelor of Audiology Speech Language Pathology Degree course is offered

at School of Rehabilitation and Behavioral Sciences, Puducherry.

1) ELIGIBILITY:

A pass in H.Sc.,/10+2 (or) an equivalent examination from a recognized Board with minimum 50% in aggregate. The candidate should have studied in Physics, Chemistry and any one of following:

Biology (or) Mathematics (or) Computer Science (or) Statistics (or) Electronics (or) Psychology (or) Biotechnology (or) any Science subject.

- 2) **AGE:** Candidates should have completed the age of 17 years on or before 31^{st} December 2024.
