- b) The candidates should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.

- ii) Candidates who have deposited their original documents with any other Institute /College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute /College / University” shall **not** be allowed to take admission in the allotted Medical College.

- b) **Allotment letter given by the DGHS for admission is subject to fulfillment of all eligibility criteria prescribed by the MCI and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund of fee, disciplinary rules and hostel rules etc.
