3) ELIGIBILITY CRITERIA FOR MD (HOMOEOPATHY) SPECIALITY

- a) The candidates must pass in BHMS / BHMS (Graded) or an equivalent Degree recognized by the Central Council of Homoeopathy & Ministry of AYUSH, Government of India, New Delhi.
- b) The candidates must have permanent registration of his / her name with any State Homoeopathy Medical Council.
- c) Candidate should have appeared / qualified in All India AYUSH Post Graduate Entrance Test (AIAPGET) 2017 conducted by All India Institute of Ayurveda, New Delhi.
- d) Candidate belonging to any State / Union Territory of India are eligible.

NOTE: Mere appearance in AIAPGET does not confer any right to the candidate for admission into MD (Homoeopathy) Specialities. The selection and admission is subject to the fulfillment of all the admission criteria on eligibility, marks in AIAPGET- 2017 / merit list, medical fitness and such other criteria as may be prescribed by the Government of India, Central Council of Homoeopathy, New Delhi and Vinayaka Missions University from time to time.

4) ELIGIBILITY CERTIFICATE

Candidate who have passed qualifying examination other than Vinayaka Missions University should obtain Eligibility Certificate from Vinayaka Missions University, Salem and submit it at the time of admission.

6) INSTRUCTIONS FOR FILLING THE APPLICATION FORM

- a) The candidates are advised to go through the prospectus carefully and acquaint themselves with all requirements with regard to the submission of the application form.
- b) All the entries in the form shall be in capital letters only.
- c) Name mentioned in the application by the candidate should be same as in the documents of 10th / 12th Mark sheet/ Degree Mark sheets/ Degree Certificate / Council Registration Certificate.
- d) The application form should be signed by the candidate.
- e) Any application form without the signature of the candidate is liable to be rejected without any intimation.
- f) Incomplete applications shall be rejected.
- g) A candidate can submit only one application for MD (Hom) specialty. The candidate of those submitting more than one application for a Speciality will be cancelled.

8) ADMISSION PROCEDURE

- a) Marks in AIAPGET - 2017 examination is an eligibility prescribed as a single entrance examination to various MD (Homoeopathy) Post Graduate Programme conducted by All India Institute of Ayurveda, New Delhi on behalf of Ministry of AYUSH, Government of India, New Delhi.
- b) Counseling / Admission call letter will be intimated in the website. Failure to report in time on the date fixed for counseling / admission can result in forfeiting his/her chance for admission.
- d) Admission shall be made strictly on the basis of merit and availability of seats. As soon as the seats are filled, the admissions shall be closed. Merely being called for and presenting oneself for counseling will not confer any right for admission.

9) IMPORTANT NOTE

- a) Candidates are advised to check the website for updates.
- b) All admissions are subject to fulfillment of all the eligibility conditions by the candidate. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) The University reserves the right to change the rules relating to admission, examination, fee structure, refunds, etc.
- d) All disputes arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor of Vinayaka Missions University and Vice-Chancellor's decision shall be final and binding.

10) VERIFICATION OF DOCUMENTS

- a) All admissions are subject to verification of the original certificates and documents of the candidates. The decision of the Vice-Chancellor shall be final regarding the eligibility of any applicant for the admission under the Vinayaka Missions University
- b) If at any time before or after admission it is found that the candidate does not meet the eligibility requirement, the seat shall be denied to him / her. Therefore, it is the responsibility of the candidates to ensure that he / she meets all the eligibility requirements.
- c) Candidate shall not be allowed to attend the counseling without producing their original certificates.
- d) When a candidate accepts the seat allotment, his/her original certificates will be retained by the University, for the period decided by the competent authority.

11) CHANGE OF NAME / DATE OF BIRTH

The name of the candidate will be registered in the records of the University as given in the Degree/ Mark Statement/ Provisional Certificate and the Date of Birth as per 10th / H.Sc /Transfer Certificate only. No request will be considered later in regard to change of Date of Birth or correction in the name of the candidate. The parents and candidates are requested to verify and confirm these entries in the relevant certificates.

13) PAYMENT OF TUITION AND OTHER FEES

Every student shall pay tuition fee and other fee, as prescribed by the University,

Within the due date notified. The fees are subject to revision as per rules of the University.

14) REFUND POLICY

15) DISCONTINUANCE FROM COURSE OF STUDY

- a) Where any student applies for discontinuance, or without any application discontinues on his / her own, from the course to which he / she has been admitted, for any reason, either after the cut-off date prescribed by the statutory authorities for admission to the first year of the course concerned or where the seat is rendered vacant without having any chance of being filled up with any other candidate from waiting list etc., such student shall have to remit the tuition fee and other applicable fees for the entire / remaining course period. Unless and until payment of all the prescribed fees for the entire / remaining course period is made to the University, such student shall not be entitled to any certificate including transfer certificate, mark sheet etc., to be issued by the University on to get back his / her original certificates deposited with the University at the time of admission.
- b) All students and parents shall be required to furnish a declaration agreeing to the above said conditions at the time of admission.

16) PREVENTION OF RAGGING

- a) 'Ragging' means indulging in any act by disorderly conduct to a student of an educational Institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to that student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such student will not in the ordinary course be willing to do. In case, the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
- b) In this context every student of the institution and his/her parents, or guardian is required to submit a combined undertaking at the time of registration / admission in prescribed format (which will be provided by the institution) which is mandatory for registration / admission.

- c) Anti ragging regulations of the University Grants Commission and Central Council of Homoeopathy are forming part of the terms of admissions and are made available to all candidates and their parents for information and compliance. All institutions are obliged to strictly adhere to anti ragging regulations.
