a) Candidates who have been allotted through centralized counseling by the MCC of DGHS, MHFW, Govt. of India, New Delhi for admission to BDS Degree Programme in the Deemed to be University for the academic year 2023 – 2024, are advised to report and complete the admission process strictly within the date and time specified in the "Allotment Letter" issued by the MCC of DGHS.

- b) The candidates should report along with original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through NEFT / RTGS for the prescribed tuition fee and other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.

- ii) Candidates who have deposited their original documents with any other Institute/ College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute / College / University" shall **not** be allowed to take admission in the allotted Dental College.
- d) Every student shall pay the tuition fee and other fees as prescribed by the University within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time either for payment of fees or submission of original certificates will be entertained under any circumstances.
- g) At the time of admission, candidate should sign declaration / undertakings declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC / DCI and observe the good conduct and behavior and that they are bound by the University rules on payment of fees / refund of fees.

3) MODE OF PAYMENT OF FEES:

a) **TUITION FEE & OTHER FEES**:

It is mandatory that the candidates should bring the prescribed tuition fee and other fees in the form of Demand Draft drawn in favour of "Vinayaka Mission's Sankarachariyar Dental College" payable at Salem or remitted through NEFT / RTGS as mentioned in the Fees structure.

4) IMPORTANT NOTE:

- a) Candidates are advised to check the website of the MCC of DGHS (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and College website: www.vmsdcsalem.com from time to time.
- b) Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the DCI and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the MCC of DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund fees, disciplinary rules and hostel rules and UGC / DCI Regulations for Curbing the Menace of Ragging etc.
- d) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University) and Vice-Chancellor's decision shall be final and binding.

5) REFUND POLICY:

S. No.	Time of Resigns / Withdraws	Refund of Amount
1	In case of re-allocation / resigns after the first round of counseling.	Rs. 25,000/- will be deducted.
2	If any candidate resigns / withdraws after second round of counseling.	No refund of Tuition Fee & Other fees.
3	Penalty to be imposed if any candidate resigns / withdraws from the course resulting in rendering the seat vacant.	If any candidate discontinues from the course and the seat is rendered vacant, the first year fees paid will be forfeited and the student has to remit the 'entire course fee' for the remaining years of the course period.
4	If any candidate resigns / withdraws after the last date of admission as prescribed by the MCC of DGHS / DCI.	The entire course fee for the remaining years of the course period has to be paid by the candidate.
