- b) The candidates should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.
- ii) Candidates who have deposited their original documents with any other Institute /College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute /College / University" shall **not** be allowed to take admission in the allotted Dental College.
- d) Every student shall pay the tuition fee and other fees, as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time either for payment of fees or submission of original certificates will be entertained under any circumstances.
- g) At the time of admission, candidates should sign declaration / undertakings declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC/DCI and observe good conduct and behavior and that they are bound by the University rules on payment of fees / refund of fees.

04) IMPORTANT NOTE:

- a) Candidates are advised to check the website of the **DGHS** (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and College website: www.vmsdcsalem.com from time to time.
- b) **Allotment letter given by the DGHS for admission is subject to fulfillment of all eligibility criteria prescribed by the DCI and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund of fee, disciplinary rules and hostel rules etc.,
- d) All the disputes/arbitration arising in the interpretation and implementation of the provisions in

this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University) and Vice-Chancellor's decision shall be final and binding.

- 5 BDS Attempt Certificate (First year to Final Year)
- 6 BDS Degree / Provisional Certificate.
- 7 BDS Internship Completion Certificate (Candidate shall complete the Internship by **31st March** of the year of admission).
- 8 Permanent / Provisional Registration Certificate issued by the DCI or any State Dental Council. Provisional Registration Certificate is acceptable only in case where candidate is undergoing internship likely to complete the same on or before **31st March** of the year of admission.
