- b) The candidate should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.
- c) i) Candidate without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.
- ii) Candidates who have deposited their original documents with any other Institute /College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute /College / University" shall **not** be allowed to take admission in the allotted Medical College.

the eligibility criteria, procedures, guidelines and directions of Medical Counseling Committee (MCC) of DGHS from time to time.
